## KEEP FOR YOUR RECORDS

1. **Product Rules:** Individual dealers/vendors may not prepare food or beverages on site. Food trailers and a concession stand will be open to the public. The sale of "Farm Fresh" products, such as eggs, requires a permit through the Greenbrier County Health Department. Knives, antique guns, muzzleloaders, bb guns, and airsoft guns are permitted. ANY OTHER WEAPONS OR COUNTERFEIT ITEMS ARE NOT PERMITTED
2. **SET UP TIME:**  
**Set up will be Thursday September 15 BETWEEN 8 AM AND 8 PM, and Friday 6:30 am – 8 am.**
3. **TEARDOWN TIME:** All vendors are asked to stay open until closing (6 pm). and are encouraged to be off the grounds by 8 pm. Saturday September 17. **Any items and/or trash left will result in a \$150 cleanup fee.**
4. **FACILITY NOTE:** Vendors will have access to a shower/restroom facility. Camping is also available for a fee.
