KEEP FOR YOUR RECORDS

- Product Rules:** Individual dealers/vendors may not prepare food or beverages on site. Food trailers and a concession stand will be open to the public. The sale of "Farm Fresh" products, such as eggs, requires a permit through the Greenbrier County Health Department. Knives, antique guns, muzzleloaders, bb guns, and airsoft guns are permitted. ANY OTHER WEAPONS OR COUNTERFEIT ITEMS ARE NOT PERMITTED.
- INDOOR vendors:** In order to have an Indoor space you **are required to stay all 3 days**. If you choose to leave early you will not be allowed to reserve an indoor space again.
- SPACE ASSIGNMENT:** Requests for a particular space may be included with this form and received in the office with payment by **April 13th**. After **April 14th** spaces will be assigned by the SFWV Staff.
- SET UP TIME:**
 - OUTDOOR VENDORS:** Returning outdoor vendors from Fall 2022, may set-up between 1PM and 5PM on Wednesday, May 17. All other outdoor vendors may set up on Thursday, May 18, from 9AM-5PM.
 - INDOOR VENDORS:** Those with trailers may set up on Wednesday May 17 between 9am and 1pm. All other indoor vendors may set up between 1PM and 5PM on Wednesday, May 17 or Thursday May 18 between 9am – 5 pm.
- TEARDOWN TIME:** All vendors are asked to stay open until 3 PM on Sunday, May 21 and are encouraged to be off the grounds by 7PM on Sunday, May 21.
- FACILITY NOTE:** Vendors will have access to a restroom facility. Camping is available for a fee.
