KEEP FOR YOUR RECORDS

1. **Product Rules:** Individual dealers/vendors may not prepare food or beverages on site. Food trailers and a concession stand will be open to the public. The sale of "Farm Fresh" products, such as eggs, requires a permit through the Greenbrier County Health Department. Knives, antique guns, muzzleloaders, bb guns, and airsoft guns are permitted. ANY OTHER WEAPONS OR COUNTERFEIT ITEMS ARE NOT PERMITTED.
2. **INDOOR vendors:** In order to have an Indoor space you **are required to stay all 2 days**. If you choose to leave early, you will not be allowed to reserve an indoor space again.
3. **OUTDOOR VENDORS HAVE TO SIGN UP FOR BOTH DAYS AND PAY AT THE TIME OF SUBMITTING YOUR APPLICATION:** Requests for a particular space may be included with this form and received in the office with payment by **Sept 4. After Sept 5th** spaces will be assigned by the SFWV Staff.
4. **SET UP TIME: All vendors may set up on Wednesday, Sept. 13th and Thursday, Sept. 14th between 9AM-5PM.**
5. **TEARDOWN TIME:** All vendors are asked to stay open until 6 PM on Saturday, Sept. 16, encouraged to be off the grounds by 8PM on Saturday Sept. 16th. **ANY ITEMS AND/OR TRASH LEFT WILL RESULT IN A \$150 CLEANUP FEE AND YOU WON'T BE ALLOWED TO COME BACK.**
6. **FACILITY NOTE:** Vendors will have access to a restroom facility. Camping is available for a fee.
