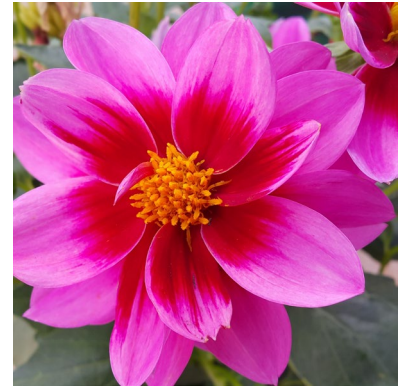

KEEP FOR YOUR RECORDS

- Product Rules:** Individual dealers/vendors may not prepare food or beverages on site. Food trailers and a concession stand will be open to the public. The sale of "Farm Fresh" products, such as eggs, requires a permit through the Greenbrier County Health Department. Knives, antique guns, muzzleloaders, bb guns, and airsoft guns are permitted. ANY OTHER WEAPONS OR COUNTERFEIT ITEMS ARE NOT PERMITTED.
- INDOOR vendors:** In order to have an Indoor space you are required to stay all 3 days. If you choose to leave early you will not be allowed to reserve an indoor space again.
- OUTDOOR VENDORS HAVE TO SIGN UP FOR ALL (3) DAYS AND PAY AT THE TIME SUBMITTING YOUR APPLICATION :** Requests for a particular space may be included with this form and received in the office with payment by **May 6. After May 7**, spaces will be assigned by the SFWV Staff.
- SET UP TIME:**
 - OUTDOOR VENDORS:** Returning outdoor vendors from Fall 2023, may set-up between 1PM and 5PM on Wednesday, May 15. All other outdoor vendors may set up on Thursday, May 16th, from 9AM-5PM.
 - INDOOR VENDORS:** All indoor vendors may set up between 1PM and 5PM on Wednesday, May 15th and Thursday May 16th.
- TEARDOWN TIME:** All vendors are asked to stay open until 3 PM on Sunday May 19th and must be off the grounds by 8PM on Sunday May 19th. **ANY ITEMS AND/OR TRASH LEFT WILL RESULT IN A \$150 CLEANUP FEE AND YOU WON'T BE ALLOWED TO COME BACK.**
- FACILITY NOTE:** Vendors will have access to a restroom facility. Camping is available for a fee.

- VENDOR PARKING:** ANY VENDOR WANTING TO BE PARKED IN THE DESIGNATED PARKING AREAS DURING THE FLEA MARKET MUST DO SO BY 8AM. NO VEHICLES ALLOWED AFTER 8AM!!!

******* All spaces will go by 2023 assignments.**

******* There will be no vehicles allowed to drive in the WV Building**

******* All Indoor vendors will have a designated area for parking. No vendors will be allowed to park around the buildings.**

All Outdoor vendors: If your vehicle/trailer does not fit in your paid space you can park in the designated parking area.
