Rules & Information

Outdoor Vendors are permitted 1 truck and/or trailer in their 20x20 space. If extra space is needed for truck/trailer inventory, then regular space fees apply. If a vehicle is parked in your space, it is not allowed to be moved after 8 am. NO EXCEPTIONS

NO ELECTRICITY PROVIDED OUTSIDE

- 1. <u>Product Rules:</u> Individual dealers/vendors may not prepare food or beverages on site. Food trailers and a concession stand will be open to the public. The sale of "Farm Fresh" products, such as eggs, requires a permit through the Greenbrier County Health Department.

 Knives, antique guns, muzzle-loaders, BB guns, and airsoft guns are permitted. ANY OTHER WEAPONS OR COUNTERFEIT ITEMS ARE NOT
- 2. Spaces: All space measurements are approximate due to layout of terrain and equipment; sizes will marginally vary.
- 3. <u>ALL VENDORS HAVE TO SIGN UP FOR ALL DAYS AND PAY AT THE TIME OF SUBMITTING YOUR APPLICATION:</u> Requests for a particular space may be included with this form and received in the office with payment by April 9th.
- **4.** Returning fall vendors applying before early bird deadline will have priority to their spots at the previous flea market. After **April 9th** spaces will be assigned by the SFWV Staff.
- 5. <u>SET UP TIME</u>: All outdoor vendors may set up on Wednesday May 7th, and Thursday May 8th between 9AM-8PM and indoor vendors between 9AM-6PM.
- 6. <u>TEARDOWN TIME</u>: All vendors are asked to stay open until 3 PM on Sunday, May.11th, and encouraged to be off the grounds by 8PM. ANY ITEMS AND/OR TRASH LEFT WILL RESULT IN A \$150 CLEANUP FEE AND THE GROUP OR INDIVIDUAL WILL NOT BE PERMITTED TO RETURN AS A VENDOR.

7. FACILTIY NOTE: Vendors will have access to a restroom facility.
