## Rules & Information

- Product Rules:** Individual dealers/vendors may not prepare food or beverages on site. Food trailers and a concession stand will be open to the public. The sale of "Farm Fresh" products, such as eggs, requires a permit through the Greenbrier County Health Department. Knives, antique guns, muzzle-loaders, BB guns, and airsoft guns are permitted. ANY OTHER WEAPONS OR COUNTERFEIT ITEMS ARE NOT PERMITTED.
- Spaces:** All space measurements are approximate. Due to the layout of terrain and equipment, sizes will marginally vary.
- ALL VENDORS HAVE TO SIGN UP FOR ALL DAYS AND PAY AT THE TIME OF SUBMITTING YOUR APPLICATION.**  
Returning Fall Vendors Applying before Early Bird deadline will have priority to their spots at the previous Flea Market. After July 25th spaces will be assigned by the SFVW Staff. **Applications must be in the office by July 25th.**
- SET UP TIME:** Outdoor vendors may set up on Wednesday, Sept. 3rd and Thursday, Sept. 4<sup>th</sup> between 9AM-8PM  
Indoor. Indoor will be between 9AM-6PM.
- WE WILL NOT BE ACCEPTING IN OFFICE APPLICATIONS AUGUST 4<sup>th</sup> – AUGUST 16<sup>TH</sup>**
- TEARDOWN TIME:** All vendors are asked to stay open until 3 PM on Sunday, Sept. 7<sup>th</sup>, encouraged to be off the grounds by 8PM on Sunday Sept. 7<sup>th</sup>. **ANY ITEMS AND/OR TRASH LEFT WILL RESULT IN A \$150 CLEANUP FEE AND THE GROUP OR INDIVIDUAL WILL NOT BE PERMITTED TO RETURN AS A VENDOR.**

7. **FACILITY NOTE:** Vendors will have access to a restroom facility.

10. **VENDOR PARKING:** ANY VENDOR WANTING TO BE PARKED IN THE DESIGNATED PARKING AREAS DURING THE FLEA MARKET MUST DO SO BY 8AM. NO VEHICLES ALLOWED AFTER 8AM!!! **You ARE NOT allowed to drive through the flea market after those hours!!!!!!!!!!!!!!**  
**Any Vendor leaving early and not staying until the end of day and driving through the market will NOT be allowed to come back.**

\*\*\*\*\* No vehicles will be permitted inside the WV Building under ANY circumstances.

\*\*\*\*\*All Indoor vendors will have a designated area for parking. No vendors will be allowed to park around the buildings.
